The NFPA 1141 also requires that vegetation growth alongside roads be cleared to minimize the likelihood of evacuation routes being blocked during wildland fire or other natural disasters.

Further, NFPA 1141 requires 2-foot curb cuts on either side of a fire lane where it connects to a road. Grade NFPA 1 sets a maximum grade (slope) of 5 percent for fire lanes. NFPA 1141 specifies a 10 percent maximum, as well as a 0.5 percent minimum to prevent pooling of water. However, some manufacturers have lower limits for specific apparatus.

With regard to the application and enforcement of this provision in the Code, a frequently asked question to NFPA staff is whether electric grills are including in this provisions. The answer is yes, they must follow the same rule as other fuel fired grills noted above. In 2006 the Code read as follows:
