Security Identification Display Area Training (SIDA) Training is required under Chapter 49 of the Code of Federal Regulations (CFR) part 1542 for badged employees requiring access into the SIDA. The training is approximately 40 minutes long and is mandatory for all first time applicants or new issues.

SIDA Badge Test - First Alarm, MAOP or Translation. Annual testing is required. Testing time: up to 3 hours. Schedule Appointment. Sterile Badge Test. Testing is required annually (every two years for Volunteers and City Employees) Testing time: up to 1.5 hours. Schedule Appointment.

The SIDA badge means the wearer can access airline ramps, so security screening is intensive. Applicants must pass an employment background check, a Security Threat Assessment, and a fingerprint-based criminal history record check. That check will cover the previous 10 years.

For initial SIDA badge issuance, once you have cleared the security clearances, you are required to take Active Shooter, Insider Threat, SIDA and Non-Movement Area Basic Training (or Non-Movement Driver Training if you drive on the AOA). All training courses provided by Access DFW must be completed with a score of 100% on the final test.

New Applicant Requirements: Step 1: Make fingerprint appointment, (SIDA & Sterile badges only) Provide two forms of valid government issued IDs, including one photo ID (e.g. driver license, passport, alien identification card, etc. Please see Acceptable Identification Documents Reference Sheet); Pay \$40 processing fee
